RESOLUTION NO. 60-23

AUTHORIZING

THE ADOPTION AND IMPLEMENTATION OF THE RECOMMENDED SERVICE CHANGES FOR THE WINTER ASSIGNMENT 2024 AND THE ASSOCIATED TITLE VI ANALYSIS

WHEREAS, the Toledo Area Regional Transit Authority (TARTA) Board of Trustees approved Resolution No. 63-22: ADOPTION OF TARTA NEXT AS DIRECTION FOR THE AUTHORITY'S SERVICE PRIORITIES AND DESIGN; and

WHEREAS, TARTA determined that the proposed changes as listed below in Section 1 are the next phase for implementing the TARTA NEXT vision; and

WHEREAS, TARPS' service area will expand along with the extension of Route 2 in accordance with the ADA complimentary paratransit 3/4 mile rule; and

WHEREAS, the TARTA Board of Trustees approved Resolution No. 41-23: AUTHORIZING THE ADOPTION OF THE PROPOSED SERVICE CHANGES AS OUTLINED IN TARTA NEXT, FOR OUR JANUARY ASSIGNMENT 2024 AND ASSOCIATED TITLE VI ANALYSIS; and

WHEREAS, TARTA analyzed the impacts of the major service changes to minority census tracks and members of our disadvantaged communities as required by the Title VI regulations; and

WHEREAS, in accordance with federal regulations and Title VI requirements, TARTA conducted public meetings and documented feedback and comments.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOLEDO AREA REGIONAL TRANSIT AUTHORITY, OHIO,

<u>SECTION 1.</u> Authorizes the Chief Executive Officer to implement the following changes effective with the Winter 2024 service change January 7, 2024:

- The extension of Route 2 to the Walmart on Navarre in Oregon
- Weekend Frequency increase for Route 52
- Removal of Route 51
- Expand TARPS service area to compliment the extension of Route 2
- Expand TARTA Flex service area to include all of the City of Oregon

<u>SECTION 2</u>. That the Board authorizes with the extension of services into Oregon including but not limited to, finalizing stop locations, implement necessary amenities such as bus

shelters, and engaging property owners regarding deploy TARTA's services.	construction related activities in order to
